

## Sports premium Impact statement 2022 – 2023

For the financial year 2022 – 2023, The Cavendish school received £16,380.

The Department for Education requires that the PE and Sport Premium must be used to fund additional and sustainable improvements to the provision of PE and sport for the benefit of primary age pupils in the 2022/23 academic year. This is with the intention of encouraging the development of healthy and active lifestyles.

What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 metres?	57%	Pupils have Autism and this often means that pupils have sensory difficulties alongside difficulties with motor coordination. This means that our pupils often need additional support in order to be able to achieve this.  The pupils are also supported into year 7 and 8 to achieve this.
